VI. Approval of the Minutes for July 24, 2017.

- Mr. Humble briefed the Board on the preliminary results of the Summer Reading Program.
- Mr. Humble briefed the Board on support he would like the library to provide to the Gulf Coast History Project as part of what Genealogy can provide without incurring extra cost beyond some labor.
- Mr. Humble shared with the Board Library Future Trend cards which were provided at the most recent PLAN conference by the American Library Association.

XI. New Business

- A motion to accept the 2017-2018 State Aid to Libraries Grant application and authorize the Chairman to sign it was made by Ms. Tobin, seconded by Ms. Fox, and passed unanimously.
- A motion was made by Dr. Temple to reauthorize the continued partnership with Oneblood.org and allow up to \$50 in fines be forgiven if a patron makes a good-faith effort to donate blood at one of the blood drives held at the library for the next three years. The motion was seconded by Ms. Fox and passed unanimously.
- A motion was made by Ms. Fox to authorize the National Library Card Month proclamation and the Teen Titans card. The motion was seconded by Dr. Temple and passed unanimously.
- Mr. Humble presented to the Board his plans for applying for a \$25,000 grant for libraries that teach coding to youth.

XII. Open Board Discussion

Mr. Humble briefed the board about the 2017-2018 library IT budget. Ms. Tobin made a
motion to pay for RFID gates for Genealogy to be funded from reserves, it was seconded
by Ms. Fox, and passed unanimously. Some parts of the IT budget changes were not
clear so the Board elected to hold a Budget Review Meeting to further review the
budget to be held on September 7, 2017 at 12:00 pm at the Pensacola Library when a
detailed backup of the changes will be provided.
