Budget Review:

- Motion made by Mr. Bryant to approve the recommended budget amendment from reserves in the amount of \$380,644.00 with \$90,000 allocated to Other Contractual Services, \$40,000.00 allocated to Machinery & Equipment, and \$250,644.00 allocated to Books, Publications and Library Materials, seconded by Dr. Guttmann, and carried unanimously, adopting the motion as presented.
- Motion made by Mr. Bryant to approve the budget as presented with the understanding that in the future the Board of Governance would like to see reoccurring operating expenses come from the current funds, seconded by Ms. Tobin, and carried unanimously, adopting the motion as presented.
- Motion made by Mr. Bryant that if additional revenue materializes, the first ten thousand dollars of additional revenues be allocated towards training, travel and per diem with any remaining amount to be put into reserves, seconded by Dr. Guttmann and carried unanimously, adopting the motion as presented.

Library Director Second Interview Process Discussion:

- Mr. Turner would like to have questions out to the Board by a week from Wednesday on June 10th. Questions from the BOG members shall be submitted to Mr. Turner by Monday June 8th.
- Ms. Wolfe and Ms. Yannuzzi will submit two or three scenarios of personnel situations and survey the staff for library patron challenges.

Ms. Yannuzzi gave an update on the Cafe project at Main Library.

Mr. Turner and Mr. Brown exhibited their Library cards and stated that all Escambia County employees should be encouraged to have one also.
