- Spending from the book budget was behind but has been caught up.
- Discussion amongst the board members and the Director regarding books that have been questioned by the public. Only one book out of the collection of 350,000 has been relocated. The library considers the publisher's recommendations for placement in the collection. Parents decide what books their child can check out. We follow a process for review and do not ban books. The board has the power to make recommendations, not override the Director's decision.
